## Planning Process and Intellectual Property

Wilderness Group works on a 2 year planning cycle in order to secure the capacity required from accommodation partners. At the point of the annual review of this agreement, both parties commit to working together for the next 2 years, barring unforeseen circumstances. If either party has any reason to reconsider the working relationship, it should be raised with the other party at the earliest possible opportunity. If the working relationship ends for any reason, the trip itineraries remain the Intellectual Property of the Wilderness Group.

## Minimum Traveller Numbers on a Departure

The standard minimum group size for a departure to be confirmed is 6 clients, so if a departure has 6 clients booked onto it, WG will assume that the departure is confirmed to run. If Duvine wishes to confirm a departure which has less than 6 clients booked onto it, Duvine must let WG know as soon as possible and the pricing will be adjusted accordingly. Prices will increase with a group size of 5 or less.

If a departure reaches the minimum number of clients to confirm the trip, then subsequently there is a cancellation that brings the trip below the minimum number, Duvine must let WG know as soon as possible whether the trip is still confirmed or not.

## Covid Policy Guidance

While the health and safety of travelers is of utmost importance, DUVINE and WG have no specific policies in place requiring that travelers or guides be fully vaccinated against Covid; or about how trips should be operated with Covid in mind.

## No Solicitation & Referral Bonus

Wilderness Group agrees not to market or sell Wilderness Group's own tours, products, or services to the Company participants before, during or after the tours. Wilderness Group further agrees not to solicit the Company participants' contact information or utilize contact information provided by the Company for any purpose other than the provision of Ground Operations.

## Guides

- All guides must be fluent in the local language as well as English.
- Additionally, they need to be knowledgeable about local history and traditions and provide general commentary throughout the tour.

- Prior to operating the first tour one guide is required to attend the Company's annual Guide Training and each guide is to have fully read the DuVine Guide Manual.
- Guides must wear DuVine gear (jersey/t-shirt) while guiding a DuVine tour
- Guides must present the standard DuVine Safety Speech to all guests
- Guides must provide DuVine guests with company branded water bottle and string bag
- When leading a DuVine tour, the van should have a DuVine sticker attached
- WG is responsible for travel costs to and from training locations. The Company will pay for food and lodging at training location
- All guides must travel with a phone; the Company requires guides to be accessible by phone or email during each tour at all times. Also, guides need to have a camera and a laptop that takes and handles video and photos
- The Company requires a bio and a photograph of each guide. Wilderness Group will provide guide names for each tour 60 days prior to departure
- If the Company receives a valid and proven complaint about a guide, the Company reserves the right to discontinue the services of said guide for future trips.
- The guide must know where the closest hospital is and what number to call in case of an emergency, including the Company's emergency response team.
- Prior to tour the guide(s) must call all vendors to confirm reservations, and study the Arrival Report
- The guide(s) must be present with the group for all included events on tour. There will be one night where the guide can be absent.
- Guide(s) must stay within 30 minutes from guest lodging every night.
- Day 1 and Tour Summary reports must be submitted via Wufoo.

## Guide Contact with Travellers Post-trip

DUVINE has advised that WG guides must not share their contact information or make contact with guests post trip.

## Trip Photography

DUVINE has advised that WG guides should take photographs on a trip (with the guest's permission), and that photographs should be shared with the partner via a Smugmug link. DUVINE to provide Smugmug links per departure. All images taken during a DUVINE tour belong to the company. No videos or photos taken during the tour can be used by the Agent for their own purposes.

As per all DUVINE departures, WG guides are to also present these images in a 'slideshow' on the last night of the tour. WG Guide(s) must upload photos to Smugmug at the end of the tour, no later than one week.



## Privacy Policy

Wilderness Group acknowledges that it shall be considered a service provider or data processor, as that term is defined under applicable Data Privacy Law which shall include, but not be limited to, the California Consumer Privacy Act ("CCPA"), the California Privacy Rights Act ("CPRA"), the Virginia Consumer Data Protection Act ("VCDPA"), the Colorado Privacy Act ("CPA"), the European Union General Data Protection Regulation (Regulation 2016/679) ("GDPR"), the European Union e-Privacy Directive (Directive 2002/58/EC), and any national laws made under or pursuant to them, and the Canadian Personal Information Protection and Electronic Documents Act ("PIPEDA"), as applicable. Notwithstanding anything herein to the contrary, the Hotel will comply with all laws and regulations applicable to its processing of personally identifiable information ("PII"), e.g. CCPA, CPA, CPRA, VCDPA, GDPR and Payment Card Industry Data Security Standards, as applicable, regarding any PII provided to the Hotel to perform its obligations under this Agreement.

PII includes, but is not limited to, first and last name, Social Security number, driver's license number, bank account number, credit card number, passport number, email address, phone number, address, birth date, and similar personal information that may reasonably identify an individual.

Wilderness Group will hold PII in strict confidence and impose confidentiality obligations on the Hotel's personnel, as applicable, who will be provided access to, or will otherwise process PII, including requiring personnel to protect all PII in accordance with the requirements of the CCPA, CPRA, CPA, VCDPA, GDPR and this Agreement.

Wilderness Group will promptly notify the Group in writing (and in any event within twenty-four (24) hours) if the Hotel has reason to believe that there has been any accidental or unauthorized access, acquisition, use, modification, disclosure, loss, destruction of, or damage to PII or any other unauthorized processing of PII.

## 2026 Day by Day Itinerary

### Day 1 - Annascaul and the Dingle Peninsula

Make your own way to Tralee via train or plane. Your guides will greet you at Tralee train station or Kerry airport and take you to lunch in a traditional Irish pub. Set off on our opening ride after a safety talk, winding our way around the many small roads called boreens that characterize the southern coast of the Dingle peninsula. Pass beautiful coves and castle ruins before rolling into the quintessential Irish village of Dingle. This evening we will experience the magic of Ireland with captivating tales from a master storyteller, bringing Irish legends to life.

Meals: Lunch / Dinner

Accomplished: 13 miles / 21 km, elevation gain: 968 feet / 295 meters

Longer Option: 22 miles / 35 km, elevation gain: 2,378 feet / 725 meters

### Day 2 - Sleah Head

Following a relaxed Irish breakfast, we hit the road to explore the beautiful Dingle Peninsula. This is Gaeltacht country where the Irish language is still widely spoken as a first language and culture and traditions remain strong. Our ride takes us west past a fascinating array of ancient sites including Iron Age forts, beehive huts, inscribed stones, and historical churches. The Peninsula culminates at the dramatic Sleah Head—Europe's most western point. We'll visit a local brewery and learn about their trade. This evening, there is time to explore the charms of Dingle Town itself, including its traditional music scene before heading out for a dinner at a celebrated seafood restaurant.

Meals: Breakfast / Lunch / Dinner

Accomplished: 26 miles / 42 km, elevation gain: 1,000 feet / 305 meters

Longer Option: 34 miles / 55 km, elevation gain: 1,312 feet / 400 meters

### Day 3 - From the Gap of Dunloe to Lakes of Killarney

Today we hit all the highlights, including the Gap of Dunloe, a private boat journey across Lough Leane with a local legend, a 15th-century castle, and a National Park. After an hour-long transfer, our ride begins on the Iveragh Peninsula, dominated by Magillicuddy's Reeks—Ireland's highest mountain range, also known as "the black stacks." Pass through the iconic Gap of Dunloe, a narrow rocky opening in the heart of the peninsula that leads to the shores of Lough Leane. A memorable boat journey carries us through Killarney National Park to the front door of Ross Castle, poised on the Lakes of Killarney.

Meals: Breakfast / Lunch / Dinner

Accomplished: 29 miles / 47 km, elevation gain: 1,781 feet / 543 meters

Longer Option: 59 miles / 95 km, elevation gain: 2,198 feet / 670 meters

## Day 4 - Conquering the Ring of Kerry

Departing Killarney, we embark on the most challenging climb of the week. Through groves of twisted oaks, the road rises past the spectacular Ladie's View to Moll's Gap. Behind us is yesterday's conquered Killarney National Park; on the other side of the gap lies one long descent to the south side of the peninsula and the picture-perfect village of Kenmare. We'll arrive in time for the farmers market that fills the square every Wednesday with local crafts and delicacies. In the afternoon, experience the thrill of a Hawk Walk on the grounds of Sheen Falls, where you can soar with majestic birds of prey amidst breathtaking scenery. Tonight, choose from a wide range of top-notch restaurants in this renowned foodie village.

Meals: Breakfast / Lunch

Accomplished: 24 miles / 38 km, elevation gain: 1,250 feet / 381 meters

Longer Option: 31 miles / 50 km, elevation gain: 1,250 feet / 381 meters

## Day 5 - The Beara Peninsula

Our final ride follows an easygoing route through the Caha mountains. We'll bike into some idyllic countryside on virtually traffic-free roads—this peninsula is the least known in Kerry and truly a hidden gem. Stop for lunch at a quaint stone cottage with fantastic views and fill up on hearty, traditional fare. As we loop back to the hotel, hop off the bikes for a visit to a French chocolatier. An afternoon pick-me-up comes in the form of Benoit's finest confections, and we'll even have the chance to craft our own chocolates. This evening, join us for a farewell dinner and toast to a week of accomplishments over a bounty of local ingredients.

Accomplished: 18 miles / 29 km, elevation gain: 1,178 feet / 359 meters

## Day 6 - Farewell to Ireland

After a relaxing Irish breakfast, say your final farewell to the Emerald Isle. We will transfer you to Killarney train station or Kerry airport where we bid you slán go fóill—until next time!
