Planning Process and Intellectual Property

Wilderness Group works on a 2 year planning cycle in order to secure the capacity required from accommodation partners. At the point of the annual review of this agreement, both parties commit to working together for the next 2 years, barring unforeseen circumstances. If either party has any reason to reconsider the working relationship, it should be raised with the other party at the earliest possible opportunity. If the working relationship ends for any reason, the trip itineraries remain the Intellectual Property of the Wilderness Group.

Minimum Traveller Numbers on a Departure

The standard minimum group size for a departure to be confirmed is 5 clients, so if a departure has 5 clients booked onto it, WG will assume that the departure is confirmed to run. If MTSI wishes to confirm a departure which has less than 5 clients booked onto it, MTSI must let WG know as soon as possible and the pricing will be adjusted accordingly. Prices will increase with a group size of 4 or less.

If a departure reaches the minimum number of clients to confirm the trip, then subsequently there is a cancellation that brings the trip below the minimum number, MTSI must let WG know as soon as possible whether the trip is still confirmed or not.
